The undersigned acknowledges that skiing, snowboarding, and snowshoeing are strenuous activities with certain inherent risks, some of which can be very serious ranging from minor strains and bruises to broken bones and catastrophic injury such as complete paralysis or even death to some participants. I freely and voluntarily accept full responsibility for all risks involved, including risks inherent in skiing, snowboarding, and snowshoeing in the ski area/mountain environment.
2. I accept my responsibility to ski, snowboard, and/or snowshoe safely at all times, to abide by the Skier Responsibility Code, and to obey all posted behavior notices and any other ski area rules and policies. Any equipment I use while skiing, snowboarding, and/or snowshoeing, I use at my own risk.
3. I agree that I will not sue or make a claim against Bellevue School District, Bellevue Ski Council, Bellevue Ski School, Ullr, Inc., Boyne USA, Inc. or any of (their/its) owners, officers, agents, or subsidiaries, including but not limited to, Ski Lifts, Inc., and the U.S. Government or any of (their/its) employees, agents, contractors, subsidiaries and officers ("Released Parties") for any loss, injury, or damage resulting from any cause including negligence, which arises out of my participation in any activity at the ski area, including but not limited to, use of the slopes, equipment, or any of the facilities or services on the premises.
4. I further agree to RELEASE, HOLD HARMLESS and INDEMNIFY Bellevue School District, Bellevue Ski Council, Bellevue Ski School, Ullr, Inc., Boyne USA, Inc. or any of (their/its) owners, officers, agents, or subsidiaries, including but not limited to, Ski Lifts, Inc., and the U.S. Government or any of (their/its) employees, agents, contractors, subsidiaries and officers ("Released Parties") for any loss, injury, or damage which arises out of my participation in any activity as described above. This Release is also binding as to any other persons, including all family members, heirs, and executors.
5. I agree that I will not sue or make a claim against the Released Parties for any loss, cost, damage or injury resulting from any cause including negligence, which arises out of or is related in any way to my travel to and from the ski area.
6. I further agree to RELEASE, HOLD HARMLESS and INDEMNIFY Released Parties for any loss, cost, damage or injury, including death, which arises out of or is related in any way to my travel to and from the ski area. This Release is also binding as to any other persons, including all family members, heirs, and executors.
7. This Release does not apply to gross negligence or intentional acts.
8. I authorize the Released Parties to administer first aid as they deem necessary. I authorize transportation to a medical facility, at my sole expense, if deemed necessary by Released Parties. Further, in the case of serious illness or injury, if I cannot be consulted, I give permission for treatment, including medical and/or surgical care necessary for my well-being, solely at my expense. I agree that upon transporting myself to any medical facility, clinic or hospital that the responsibility of the Released Parties shall be totally fulfilled and the Released Parties shall have no further responsibility
